

CONFIDENTIALITY POLICY

INTRODUCTION

B2Broker Company (hereinafter - the Company) is committed to privacy issues and considers the preservation of your personal confidential information as its main task during the implementation of all activities.

By providing services to its clients, we collect and store their personal data. That is why we would like to acquaint you with the privacy policy, which is also applicable in relation to you, if you decide to use or use the services of our Company.

Please note that this Policy only applies to websites that are directly supported by the B2Broker and does not extend to other organizations and individuals to which we can refer on our banner or link on our Website.

FEE OF PERSONAL INFORMATION

To provide any products or services, we will need to obtain from you the following information that will be used for administrative, legal or other purposes related to the provision of services:

- Personal data: name, address, email address, etc. in accordance with the policy of "Know Your Client" (KYC);
- Financial data: data about your trading activity, account status, balance, etc. Your personal data will be stored, handled and protected in accordance with the laws and regulations on the protection of personal information under the jurisdiction of the State in whose territory the head office of B2Broker is located.

COOKIES USAGE

In order to enhance the usage of web - sites, B2Broker websites use small files - cookies. You can change your browser settings and block the reception of cookies. However, we do not recommend you to limit or disable the cookie-files, as this can affect your work with the website of B2Broker and cause improper operation of some functions and services.

USAGE OF PERSONAL DATA

Private information is used by the Company only to ensure a high quality of services and protection of rights and legitimate interests of the Company. This information is necessary, for example, to confirm the identity and contact information.

It may also be required to register and set up your account, making a number and a secure password for it, maintain your account activity, to provide information on the account, as well as to improve the quality of services and notification of additional products, services and promotions that can pose interest for you.

TRANSFER OF DATA TO THIRD PARTIES

B2Broker take all necessary measures to maintain a high level of security of your personal data. Our employes, security officers and / or representatives are responsible for complete confidentiality of your personal information and disclose it to third parties under certain circumstances and in accordance with the relevant laws. Please be advised that we may disclose personal information such as name, postal address and e-mail, etc. to third parties authorized by the B2Broker on the basis of the existing contractual relationship with them. We may disclose your personal data our associated parties or its affiliates, agents or other authorized organizations or individuals to ensure we would fulfill all direct or not direct obligations concerning the provision of our services to you. We guarantee that all of the persons referred to in this notice and adhere to this policy shall also take all necessary steps to protect your privacy. In case of necessity, we are required to disclose your personal information on request of official regulatory and law enforcement authorities.
